The designation falls within a description of designations for which the Secretary of State has issued a General Approval under Section 82 of the Act, namely the Licensing of Houses in Multiple Occupation and Selective Licensing of Other Residential Accommodation (England) General Approval 2015. Therefore, the designation need not be confirmed and will come into force on 1<sup>st</sup> April 2024 and unless previously revoked, this designation shall cease to have effect on 31st March 2029.

Upon the designation coming into force on 1<sup>st</sup> April 2024 any person having control of or managing a licensable property without a licence is liable to prosecution under Section 95(1) of the Act and upon summary conviction is liable to an unlimited fine or under Section 249A a financial penalty not exceeding £30,000. In addition, such a person may be required, pursuant to a rent repayment order, to repay up to 12 months' rent under the provisions of Section 96 and Section 97 of the Act.
