- 1.0 The Wirral Unitary Development Plan (UDP), adopted in 2000, provides protection for sites of special local importance for nature conservation, known as Sites of Biological Importance (SBIs) in Policy NC5. The original schedule of SBIs is identified in the UDP in Proposal NC6 and on the Proposals Map.
- 1.1 In February 2011 Wirral Borough Council formally agreed a revised schedule of Sites of Biological Importance, as a material consideration for use by Planning Committee in the determination of individual planning applications.
- 1.3 The revised schedule of SBIs is set out in Appendix 1 of this report.

# 2.0 Background

2.1 Wirral's Sites of Biological Importance were originally drawn up by Cheshire Wildlife Trust in the late 1980's replacing the wildlife sites system previously developed by Merseyside County Council. This system has been maintained on a voluntary basis, initially by Wirral Wildlife (the Wirral group of the Cheshire Wildlife Trust), with the assistance of other specialist wildlife groups, and more recently by the Wirral Local Wildlife Sites Partnership, established in 2007.

### 3.0 2011 Review

- 3.1 Since the adoption of the UDP sites have continued to be surveyed on a rolling basis. This has identified a number of proposed changes to the original schedule of SBIs, including existing sites that no longer meet the criteria for inclusion and should be removed from the schedule, sites where boundary modifications are required to reflect current nature conservation value and additional sites that now meet the criteria for inclusion as SBIs.
- 3.2 Full details of the proposed changes were presented to Wirral Council's Cabinet on 13<sup>th</sup> January 2011 in a report titled *Local Development Framework* for Wirral Sites of Biological Importance Update, which can be viewed at:

3.3 The Local Sites Partnership are proposing to review the criteria for selecting SBIs follow the publication of guidance on local sites by DEFRA in 2006. In time all SBIs would need to be reassessed against any revised selection criteria. However, in the meantime, the original site selection criteria employed in the assessment of SBIs in the UDP have been used as the basis for the 2011 review. The criteria were developed by Wirral Wildlife, the Wirral Group of Cheshire Wildlife Trust with assistance from specialist wildlife groups such as Wirral and West Cheshire Badger Group, Merseyside Bat Group and the British Trust for Ornithology and were agreed with English Nature (Natural England) and Wirral Borough Council.

# 4.0 Criteria for Selection of Sites of Biological Importance

- 4.1 Sites of Biological Importance should include all good examples of all habitat types represented on Wirral which are not already Sites of Special Scientific Interest. They are selected solely upon ecological merit, although other factors such as geology, history and management may influence their overall value.
- 4.2 Four primary attributes are used to select sites. Individual sites would normally possess more than one of these. These attributes cannot be ranked in order of importance; all have to be considered in evaluating a site for SBI status. Ownership and planning status are not considered in evaluating sites.

# Primary Attributes

- A) Presence of a high quality example of at least one habitat: sites will be among the best local examples of the habitat under consideration. Scarce habitats (locally / nationally) have increased value. Habitats where natural processes are likely to lead to rapid loss of ecological interest are usually less valuable, except where the process of ecological change is itself of interest.
- B) Presence of a high diversity of the species to be expected in that habitat. Number of species alone is not a sufficient guide; a heathland, for example, will have less plant species than a woodland, but still may be a very good example of a heathland.
- C) Presence of good examples of a variety of habitats. A varied site, providing for a range of species, is often of more value than a less diverse area.
- D) Presence of locally or nationally rare or uncommon species, particularly those that are protected by law e.g. Badgers, Great Crested Newts, Bats.

### **Subsidiary Factors**

- 4.3 Other considerations may affect the value of a site: -
  - 1) Large size bigger sites tend to support more animal species and are able to sustain those animals which require large territories.
  - 2) Potential for or existence of good management tending to increase the wildlife value.
  - 3) Key position as a link between other wildlife sites.
  - 4) Presence of geological and / or physiographical features.
  - 5) Educational value for demonstrating biological or other scientific features accessibility is important.
  - 6) Scientific recorded history sites with historical scientific records have enhanced value.

- 4.4 In applying these criteria to Wirral Metropolitan Borough, certain general principles can be drawn for various habitats.
- 4.5 **Woodland**: Since semi-natural woodland is in short supply in Wirral, SBI woodlands should include:
  - i. all woodland which by presence of indicator species appears to be ancient and/or semi-natural;
  - ii. all other woodlands of high species diversity (plant/animal), especially where rare species are present.
- 4.6 **Lowland Heath**: This is a nationally and internationally rare habitat. Wirral has good examples of a particular maritime type. SBIs will include:
  - i. all good examples over 2ha.;
  - ii. down-graded heathland of this size where birch/pine invasion is the problem, as this can be reversed by management to control the trees.
- 4.7 **Coastal**: Much of the coast is heavily altered: SBIs will seek to protect all good examples of the following which are not within the SSSIs:
  - i. sand dune, both mobile and fixed, including slacks, maritime calcareous grassland and other features of the sand dune system;
  - ii. clay cliffs;
  - iii. rocky shore;
  - iv. salt marsh.
- 4.7 **Grassland**: Unimproved / semi-improved grassland is extremely rare on Wirral, except for the small SSSI Meols Meadow. Any diverse grassland discovered in future should be scheduled as an SBI. Grassland diversity can now be judged against the National Vegetation Classification.
- 4.8 **Fresh water and wetlands**: These are represented in Wirral largely by the numerous field ponds. These are vital to local wildlife and of national interest as north-west England has the greatest density of ponds in the country. The number of ponds has declined greatly in the last 30 years (by around 50%), so that protection and management of the resource is important. Various pond surveys have been carried out, but it is always possible that further good examples will become known or existing ponds improved by good management. Special value will be attached to:
  - i. ponds supporting good populations of Great Crested Newts (legally protected with the main populations in N.W. England);
  - ii. clusters of ponds or ones adjacent to other valuable wildlife habitats;
  - iii. ponds in an early stage of the succession to dry land (i.e. early in their natural life cycle);
  - iv. ponds under active good management.
