Section 2: What Council proposal is being assessed?

Wirral Individual Placement Support (IPS) Programme Grant

In January 2021, the government announced an additional £148 million funding to reduce drug-related crime and health harm. This included an announcement of further funding for Project ADDER (Addiction, Diversion, Disruption, Enforcement and Recovery), a joint Home Office, Department for Health and Social Care and Public Health England programme. Wirral was selected to be a Project ADDER site based on consideration of key indicators including high prevalence of drug misuse, high levels of drug-related deaths and significant levels of drug-related offending.

Coming alongside this was an additional National Grant funding programme to improve the capability and capacity of treatment systems to support people recovering from drug and alcohol misuse into employment. This grant programme recognises that gaining employment is a key factor in enabling people to successfully maintain their own recovery. Local authority areas were invited and encouraged to join this programme. Wirral is 1 of the 48 LAs that took up this invitation in 2021-22 and as a consequence was awarded a grant of £135K per annum until 2024-25. This is a figure arrived at by OHID (Office for Health Improvement and Disparities) using a formula which factors in the number of people accessing the Wirral treatment service and is calculated to provide for two full time employment advisors and a team leader. These posts have been appointed to.

A specific IPS (Individual Placement Support) programme group has been established and is monitoring the development of the delivery and activity of the Wirral service. it meets regularly, originally monthly but reducing to 2 monthly as the programme has bedded in. This group will now report to the regular (currently monthly) Wirral ADDER Programme Delivery Partnership Steering group. This includes a wide range of partners and among them will be representation from agencies and services working with underserved groups. Equality of access will be a standing item on the agenda.

Section 4b: If you think there is no negative impact, what is your reasoning behind this?

This programme is bringing very valuable new capacity and quality to this critical service delivery and support. This will make a positive impact on all communities, in particular on those communities with higher levels of social deprivation and health inequality. The increasing capacity of this developing programme, along with the wide involvement of partners, will also increase inclusion.
