Summary of Wirral Council consultation on CCTV







311 respondents completed the multiple-choice survey and the responses to each of the four questions are listed below.


Q1 Wirral Council should use CCTV cameras to monitor activity in public places for the purpose of reducing, deterring, and detecting crime and anti-





Q2 Clearly visible CCTV monitoring in public places reduces crime and antisocial behaviour





Comments from respondents regarding CCTV

Subject: Proposed Oxton Village CCTV

Text: "As an Oxton resident of many years I, personally, feel safe in our lovely village but sadly some of our local businesses have been victims of armed, threatening or damaging robberies. Oxton appears to be a soft target for criminals so CCTV would be a deterrent. It would also discourage Anti Social Behaviour which I believe afflicts residents in the centre sometimes. Everyone I've spoken to shares my feelings on this."

Selection of comments from CCTV Facebook post:

"We need them in Birkenhead Park covering pathways also with lighting. We need safe spaces for everyone."

"We have been asking for CCTV in Demesne Street/Toronto Street for years. As the cars are getting vandalised all the time."

The survey results show overwhelming support for CCTV as a contributory factor in reducing crime and ASB as well as reducing the fear of crime and ASB with an average of 96.2% positive responses across the four questions.

There were no negative comments, issues or concerns raised with any of the proposed new CCTV sites.
