WIRRAL COUNCIL – DESIGNATION OF AREAS FOR SELECTIVE LICENSING SECTION 80, HOUSING ACT 2004

Notice is hereby given that on the 24th day of June 2025 Wirral Council (Town Hall, Brighton Street, Wallasey, CH44 8ED) in exercise of its powers under Section 80 of the Housing Act 2004 ("the Act") designated 6 areas, namely parts of Birkenhead and Wallasey described in the Schedule below as being subject to selective licensing from 1st October 2025.

The designation may be inspected on the notice board outside **Wallasey Town Hall**, **Brighton Street**, **Wallasey**, **CH44 8ED**.

If you are a landlord, a person managing a property, or a tenant of a property within the areas of the designation you are advised to seek advice from the Council on whether your property is affected by the designation.

The designation falls within a description of designations for which the Secretary of State has issued a General Approval under Section 82 of the Act, namely the Licensing of Houses in Multiple Occupation and Selective Licensing of Other Residential Accommodation (England) General Approval 2015. Therefore, the designation need not be confirmed and will come into force on 1st October 2025 and unless previously revoked, this designation shall cease to have effect on 30th September 2030.

Upon the designation coming into force on 1st October 2025 any person having control of or managing a licensable property without a licence is liable to prosecution under Section 95(1) of the Act and upon summary conviction is liable to an unlimited fine or under Section 249A a financial penalty not exceeding £30,000. In addition, such a person may be required, pursuant to a rent repayment order, to repay up to 12 months' rent under the provisions of Section 96 and Section 97 of the Act.
