Please be as precise as possible.</p>	<p>The position is unclear from Wirral, the PPOSS (2016 and 2021) advises that Noctorum Field should be a playing pitch that is retained, given the deficiency of sports pitches in the local area, but the current local plan is removing it from such protection and then allocating it as green open space. This is in the context that Wirral Council sought to object to the loss of the sport pitch due to a known deficiency.</p> <p>The Planning Practice Guidance advises that land in private ownership can be considered for local green space designation, including land with no public access. Again, we consider that the proposed designation of the site in the Local Plan points to a misinterpretation of the national guidance in respect of land in private ownership. Whilst land in private ownership can be considered for local green space designation, this does not mean the private ownership of a site should be disregarded. We consider that land with no public access considered for designation would need to be of exceptional and demonstrable importance to the local community for designation to be appropriate. The private ownership and lack of public access was an important consideration in our assessment of whether the site meets the local green space criteria set out in the NPPF, that informed our conclusion that the amenity grassland/playing fields area of the site does not meet the NPPF criteria for Local Green Space designation.</p> <p>We consider that the Council has not engaged with Birkenhead School in any meaningful way with regards to the proposed designation of the site and in no way agreed a way forward as is recommended in the LGSD. Birkenhead School was not notified when the site was put forward for designation. The Council consulted on the LGSD and the draft assessment of the site in July 2021, which Birkenhead School responded to. We acknowledge that limited amendments to the final LGSD were subsequently made.</p> <p>The assessment of the site contained within the LGSD report is limited and a detailed site analysis was either not completed by the Council or was or not made available publicly or to Birkenhead School as part of the emerging Local Plan evidence base.</p> <p>We understand from the LGSD that the main thrust of the sites inclusion was pursued by the opposition group to the aforementioned planning application, commonly known as the NRRRA. To note the NRRRA are an active opposition group who object to any release of the Noctorum Field for development and want to see it preservation. Therefore it is very disappointing that the Council (and LUC as their consultant) actively ensued engagement with a third party group instead of proper and reasonable engagement with the landowner, who are very well respected education provided and stakeholder in the wider community .</p> <p>Birkenhead School has been afforded limited opportunity to inform and respond to the Council's assessment of the site, extending to this relatively late submission draft stage of the Local Plan preparation, and to challenge the proposed Local Green Space designation. We contend that the approach by the Council is seriously flawed and is unsound and requires fundamental review before the site can be considered for designation.
