Summary

Social Inclusion - Positive, medium to long-term, permanent effect. The policy is likely to have positive impacts on all five elements of social inclusion and indicates a commitment to deliver sites to meet objectively assessed needs.

Sustainable Consumption and Production - No significant effect.

Environmental Protection and Enhancement - Positive, medium to long-term, permanent effect. Any direct impact will be addressed through other policies in the plan.

Natural Resources - Positive, medium to long-term, permanent effect on sustainable drainage and water conservation; waste generation and recycling; and flooding and natural hazards but uncertain effect on previously developed land and reliance on non-renewable energy sources, as the policy cannot guarantee the use of previously developed sites, which may not be suitable for Gypsy and Traveller accommodation and which could only be partly addressed by Policy CS19 (Housing Implementation Plan) or the promotion and use of non-renewable energy sources, which may not be appropriate on particular sites and which could only be partly addressed through Policy CS43 (Design, Heritage and Amenity).

Quality of Life - Positive, medium to long-term, permanent effect on local distinctiveness and crime prevention but uncertain effect on general attractiveness owing to the uncertain impact on local perceptions, even if relevant safeguards are secured through the other policies of the plan, including Policy CS24 (Criteria for Gypsies and Travellers).
