LOCAL DEVELOPMENT FRAMEWORK FOR WIRRAL – PUBLICATION OF PROPOSED SUBMISSION DRAFT CORE STRATEGY LOCAL PLAN

The Council has published the draft Core Strategy Local Plan that it proposes to submit to the Secretary of State for public examination by an independent Planning Inspector. Your comments are invited on the draft Strategy.

The Core Strategy is intended to replace the strategic policies contained within the Unitary Development Plan for Wirral adopted in February 2000 and will provide the long term direction for future development and investment within the Metropolitan Borough of Wirral over the next fifteen years and beyond. When adopted, the Core Strategy will contribute towards decisions on individual planning applications and will be used to guide the identification of site specific land allocations.
