Because in Eastham most of the green belt that surrounds the Conservation Area has been identified as weakly performing, this therefore increases the possibility of development which is at odds with the policy of:- "To preserve and enhance the character and appearance of the Conservation Areas at Port Sunlight, Bromborough Pool, Bromborough Village and Eastham Village and the setting of other designated and un-designated heritage assets". Eastham Village cannot be divorced from its surroundings. There can be no development in the green belt that encloses Eastham Village. Eastham is also mentioned under the Rural Areas heading. This means that presumably that it should be reinstated in the 'Rural' classification as has been called for elsewhere in this response. According to the local plan, "culture and tourism development (including theatres museums, galleries and concert halls, hotels and conference facilities) fall within the definition of main town centre uses. As such, these uses should be located in town centres as a first preference." Port Sunlight village was built with a theatre, gallery, concert hall, and a coaching in. Adaptive use of listed buildings within the village means that there is also a museum, events venue and hotel/conferencing facility within the conservation area. PSVT does not believe that "culture and tourism development" should be restricted to main town centre uses. These uses were envisioned as key aspects to life in Port Sunlight in Victorian and Edwardian times and this remains the case today. PSVT supports complementary uses through adaptive use or limited new development within the village.
