This has allowed a unique flora and fauna to grow up which has been able to flourish. You will notice, possibly unique to the Wirral, mounds rising up in the fields. These have been constructed by ants (some may be up to 100 years old) and have a very delicate ecosystem only appearing on unfarmed land. In addition to this there are Badgers who use the land (video evidence available in the garden of no. 2 Abbey Road). There are also bats, foxes, many varieties of birds including owls, woodpeckers and birds of prey. There are established trees, again some dating back to early 20th century. Unlike the parks and other land in west Kirby, it is not frequented by the general public, however, the fields are a well know public landmark, as they are a focal point as you drive along Grange Road when you either enter or leave West Kirby. They give an open and welcoming impression of West Kirby which could be lost forever.
