These include enhancements to the visual character of the Green Belt such as identifying and enhancing important views across the landholding, through the careful design of any new landscapes or built development and the creation of accessible view points on the footpath network, or landscape design including the planting of new areas of woodland to screen ugly elements such as the M53 motorway at Storeton. Such an Estate-wide strategy comprises the positive planning in support sustainable development encouraged by the Framework. The Council's Preferred Approach outlines how a review of the Council's local non-statutory designation of Areas of Special Landscape Value (ASLV) is required following the introduction of the phrase 'valued landscapes' in paragraph 170 of the Framework. However, we wish to stress the nuance in that paragraph that planning policies should contribute to and enhance the natural and local environment by "protecting and enhancing valued landscapes (in a manner commensurate with their statutory status or identified quality in the development plan)" (our emphasis).
