Since there is little choice over where networks can go to link existing sites, it is vital that proposed development does not cut any such links. This Study, only commissioned in February 2020, is not part of this Consultation, and won't be complete by the next stage of the LP (Reg 19). This is not good enough: this information must be taken into account before further decisions are made about location of development, to achieve a "sound" Plan. If any greenfield development occurs, adequate buffer zones are essential along all watercourses, LWS, SSSIs and other priority habitats. Because of the pressure to fell "dangerous" trees within falling distance of public areas, houses and gardens, it is vital all habitats involving trees have enough buffer (of shrubs, grassland, etc.) with no development within tree-falling distance i.e.50m – same width for all natural assets. Where water tables of wetlands may be affected, e.g. Thurstaston Common damp heathland, buffers may need to be even larger, depending on underground hydrology. We appreciate the Evidence Base includes the 'Wirral Landscape Character Assessment 2019', 'Draft Wirral Open Space Assessment 2019' and 'Wirral Strategic Flood Risk Assessment 2019'.
