1248571	LPIO-24546		Gypsies and Travellers: With regards to Q5.6 (Meeting needs of Gypsies and Travellers), it is noted that evidence base document H4 – Wirral Gypsy and Traveller Accommodation Assessment 2019, (GTAA) identifies a need for 10 pitches for those who meet the definition and 3 pitches for those who do not. Although the approach in the Issues and Options Consultation is to rely on a criteria based policy and/or meet the need through general housing policies, this would not necessarily meet the needs identified in the evidence base. The GTAA states the need arises from an extended family group, but also the reason for not making provision is that there are no public or private sites in Wirral. The Local Plan (especially if the option of releasing strategic Green Belt is pursued) provides the opportunity to positively plan for this need, in line with the national Planning Policy for Traveller Sites and the NPPF.
