

# Application for Review of Decision Relating to Home to School Transport for Pupils

#### Information for parents/carers

This form should be completed if you wish to request that the decision regarding provision of home to school transport be reviewed.

Admission to a school does not guarantee that a pupil will be awarded home to school transport. The provision of home to school transport is determined by the eligibility criteria set out in the Wirral Council, Children and Young People's Services, Home to School Transport Policy (2014 onwards). Copies of this document are available on the Council's website at www.wirral.gov.uk or by contacting a member of the Home to School Transport Team.

#### Information required when submitting an application for review

- State why you disagree with the decision not to award home to school transport for your child.
- If home to school transport has been awarded and you disagree with the mode of transport, state why and give reasons for this.
- State why you believe that home to school transport or an alternative mode of transport should be awarded to your child.
- Supply details of any relevant medical and professional advice to support your request for a review.

Please note that you should provide evidence to support the reasons you have detailed in your application for review, this could include current medical evidence or current advice from the professionals involved with your child. Please note that if sufficient evidence is not provided to support your appeal, a decision on your appeal may be deferred until the information is provided.

Applications for a review will be referred to the Council's Two Stage Review and Appeal Process. Please use the form to submit your application for a review and attach any relevant medical and professional advice as appendices.
