The benefits set out above will form part of the contractual framework that exists between the company and the council. Through client management and also through a shareholder committee, the company will be monitored to ensure that the benefits are delivered.

This company is focussed on the regeneration of parts of the borough and as such it is expected to make a positive difference to the lives of all residents. Additionally it will provide income to the council to be spent on key services. There is always a risk that development companies create environmental issues such as noise. I have considered whether this might have an impact on any specific groups but do not consider that it will.

A number of local authorities including; Salford, Manchester, Liverpool, Leeds and Birmingham have created joint venture development companies. Discussion have taken place with each of these councils. Additionally consultation has taken place with GVA who are providing advice to the council.
